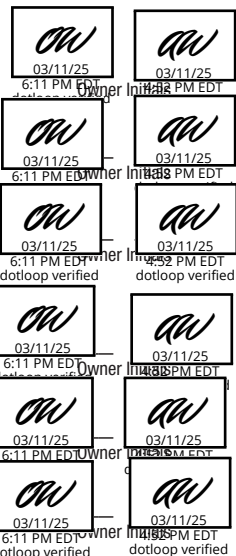

MIAMI MLS requires a listing broker to report an exclusive listing to MLS and to make the property available for showings. The **Coming Soon** Status is not intended to give the listing brokerage an advantage in finding a buyer for the property to the detriment of cooperating brokers, nor is it intended to circumvent the sale of the property on an open market. "Coming Soon" status provides a method for listing agents to notify other cooperating brokers of properties that will be made fully available for showing. NOTE: Violations of MIAMI MLS Rules and Regulations covering **Coming Soon** Status result in a minimum \$1000 Fine.

Note: Completed form must be uploaded as an attachment to the listing upon submission to MIAMI MLS. Failure to attach completed form will result in \$1000 Fine as per MIAMI MLS Rules and Regulations.



The **Coming Soon** Status will automatically become a fully Active listing on its Go Live Date. The Go Live Date: _____ cannot be greater than 21 days from MLS Entry Date.

Properties in **Coming Soon** Status cannot be shown by anyone this includes Open Houses. Any showing of a property in **Coming Soon** status disqualifies the property from this status and must immediately be changed to Active status.

If the listing broker receives any offers on the property during the **Coming Soon** Status the listing broker is required to report offers to the Seller. The seller(s) and listing agent agree no offers will be **accepted** while listing status is **Coming Soon** and that the listing status must be changed to Active before acceptance of any offer.

As soon as the listed property is available for showings, the status of the listing must be changed to Active.

If the property is not ready for showings upon reaching the Go Live Date, the listing agent can change the listing status to withdrawn from the MIAMI MLS.

A property can only be listed in the **Coming Soon** Status once per year unless the property has been sold or rented or the property is listed with a new brokerage firm.
